

Release, Assumption of Risk, Waiver and Indemnification

This document waives important legal rights. Read it carefully before signing.

Every Entry at a schooling show or clinic or other event held by the The Elegant Rider (aka Simone Windeler) and Arkansas Valley Dressage Association of Canon City shall constitute an agreement and affirmation for all participants (which include without limitation, the owner, lessee, trainer, manager, agent, coach, driver, handler and the horse). This agreement is binding for themselves, their principles, representatives, employees and agents. They (1) Shall be subject to the local rules of the competition. (2) Agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death, and by participating they expressly assume any and all risks of injury or loss, and they agree to hold the The Elegant Rider and Arkansas Valley Dressage Association of Canon City, the competition and their officials, directors, employees and agents harmless from and against all claims including claims based in negligence, breach of contract, strict liability and/or otherwise for any injury or loss suffered during or in connection with the competition, officials, directors, employees, agents of the competition.

Under Colorado Law an Equine Professional is not liable for an injury to or the death of a participant in equine activities. Pursuant to Section 13-21-119 Colorado Revised Statutes.

I AGREE in consideration for my participation in this Competition/clinic/symposium or other event to the following:

I AGREE that the "The Elegant Rider and Arkansas Valley Dressage Association of Canon City" and "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations.

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").

I AGREE to hold harmless and release the The Elegant Rider and Arkansas Valley Dressage Association of Canon City and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of the The Elegant Rider and Arkansas Valley Dressage Association of Canon City or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the The Elegant Rider and Arkansas Valley Dressage Association of Canon City or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the The Elegant Rider and Arkansas Valley Dressage Association of Canon City and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Competition.

I have read the USEF Rules about protective equipment, including GR801 and, if applicable, EV114 and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the The Elegant Rider and Arkansas Valley Dressage Association of Canon City strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of

the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf. I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

BY SIGNING BELOW, I AGREE to be bound by all applicable Federation Rules and all terms and provisions of this entry blank and all terms and provisions of this Prize List.

Addendum for COVID-19

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact.

As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Simone Windeler (aka The Elegant Rider) and Arkansas Valley Dressage Association of Canon City have put in place preventative measures to reduce the spread of COVID-19; however, Simone Windeler cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending a riding lesson or clinic or show with Simone Windeler or at Arkansas Valley Dressage Association of Canon City could increase your risk and your minor (if applicable)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I or my minor may be exposed to or infected by COVID-19 by attending lessons or clinics or shows with Simone Windeler or at Arkansas Valley Dressage Association of Canon City and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Simone Windeler, Arkansas Valley Dressage Association of Canon City, employees, volunteers, and clinic or lesson or show participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself or my minor (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my minor may experience or incur in connection with my or my minors attendance at lessons or clinics or shows ("Claims").

On my behalf, and on behalf of my minor, I hereby release, covenant not to sue, discharge, and hold harmless Simone Windeler, The Elegant Rider, Arkansas Valley Dressage Association of Canon City, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Simone Windeler, The Elegant Rider, Arkansas Valley Dressage Association of Canon City employees, agents, and

representatives, whether a COVID-19 infection occurs before, during, or after participation in any lesson or clinic or show.
